

BKA KODÁLY CERTIFICATE COURSE - fees for 2017/18

Level 2 (Primary)

A deposit of £100 is required to secure your booking. Please complete the [Kodály Summer School](#) application form.

PART ONE (a) at the BKA SUMMER SCHOOL

Students undertaking Level 2 of the Certificate Course must attend from Monday 21 to Friday 25 August.

RESIDENT (arriving Sunday night, 20 August) - fees including break refreshments and meals:

With Conference accommodation: £593 (£539 if qualifying for discount)

With Economy accommodation (limited availability): £563 (£509)

OR

NON-RESIDENT: £455 (£414) (includes break refreshments and lunches/suppers from Mon 21 Aug)

If you attend the full duration of the Summer School (Wed 16 to Fri 25 August), rather than just the period required for the Certificate Course, the fees payable are

RESIDENT

With Conference accommodation: £1,055 (£959 if qualifying for discount)

With Economy accommodation: £1,001 (£905)

OR

NON-RESIDENT: £807 (£734)

All Summer School payments must be complete by 14 August 2017.

(resident at Summer School – Conference) £1,100 (£1,046 if qualifying for Summer School discount)

(resident at Summer School – Economy) £1,070 (£1,016)

(non-resident at Summer School) £962 (£921)

For students attending the full duration of the Summer School, higher fees apply (see above)

PART TWO

- Required attendance at Study/Assessment Weekend (2-3 June 2018 tbc)
- Mentoring
- Marking
- Musicianship Assessment (if applicable): **additional £80**

TOTAL CHARGES FOR CERTIFICATE COURSE (Level 1) including required period at Summer School

(resident at Summer School - Conference) £2,027 (£1,973 if qualifying for Summer School discount)

(resident at Summer School – Economy) £1,997 (£1,943)

(non-resident at Summer School) £1,889 (£1,848)

Add £80 to all the above for Musicianship Assessment if applicable

NB When estimating total financial investment in the 2017-18 Certificate Course, students should allow for the cost of travel and any other expenses for Study Weekends, musicianship assessment and lesson observations. Except for the Summer School and Spring Course, the cost of any accommodation needed by students (eg in respect of Study/Assessment weekends) is not covered by the quoted fees.
